




Organization of Civil Aviation in BiH

BHDCA ORGANIZATION





 The seat of the BHDCA shall be in Banja Luka. BHDCA shall have regional offices situated in Sarajevo and Mostar



- Employees in regional offices report to their respective Head of Section or Head of Department in the Headquarters.
- BHDCA Regional Offices consist of number of separately located working positions fully integrated in the BHDCA workflow.



ORGANIZATION OF THE AIR NAVIGATION AND AERODROMES DIVISION (ANAD)



Aerodrome Section- AGA

- Head of aerodrome section AGA inspector
- Expert for aerodrome infrastructure and certification AGA inspector
- Expert for aerodromes, heliports, airfields and terrains- AGA inspector
- Expert for aerodrome equipment and services AGA inspector
- Airport slots and approval coordinator
 - + Extern Aerodrome Experts- AGL, RFFS, etc.



RESPONSIBILITIES OF AERODROME SECTION;

- Implements provision of BiH Aviation Law,
- Follows international standards and recommended practices in the area of aerodromes and implements them in local legislation,
- Develops proposals for improvement area of safety management systems (SMS) at aerodromes,
- Develops proposals of by-laws for the area of aerodromes, heliports, airfields and terrains,
- ➤ Conducts procedure for issuance of certificates of compliance for airports, heliports, airfields and terrains,
- Develops and implements plans for regular and contigency supervision throught inspections,
- Conducts procedure for issuance of approval for construction of facilities in the vicinity of an aerodrome, heliports, airfields and terrains,
- ➤ Performs activities and analyses related to noise abatement and environmental protection around aerodromes,
- ➤ Monitors conditions and quality of operations from aerodrome personnel and services,




RESPONSIBILITIES OF AERODROME SECTION;

- Supervises technical and other conditions required for safe handling of aircraft, passengers and goods at airport,
- Monitors performance of aerodrome services in relation to safety, condition of devices and equipment,
- ➤ Coordinates slot allocation at airports in BiH,
- > Develops proposals of bylaws for the area of flight approvals,
- Develops proposals for improvement of work organization and methodology within the area of flight approvals,
- Conducts procedure for development of flight approval plan for scheduled air traffic and issuance of approval for non-scheduled traffic

"International and national air traffic within Bosnia and Herzegovina shall only be allowed at airports in possession of an Airport Certificate issued by the BHDCA."

(Article 37. (1) BH Aviation Law)

SPECIFIKACIJA USLOVA ZA KORIŠTENJE AERODROMA SA POTVRDOM ZA JAVNU UPORABU

J.P. Međunarodni Aerodrom Tuzla d.o.o. Tuzla (Naziv aerodroma)

Sukladno sa odredbama člana 14. Zakona o zrakoplovstvu BiH ("Službeni glasnik BiH" broj 2/2/04) i Pravilnika o načinu i uslovima izdavanja potvrde za aerodrom. Direkcija za civilno zrakoplovstvo BiH izdaje potvrdu za aerodrom, koji će biti konšten kao mjesto polijetanja i siljetanja zrakoplova maksimalne dozvoljene težine Tip zrakoplova: ATR-72 i dužine Tip zrakoplova: ATR-72, koji se koriste s ciljem javnog prometa putnika i roba ili s ciljem davanja instrukcija letenja za osposobljavanje profesionalnog letačkog osoblja i sticanja ovlaštenja pod sljedećim uslovima:

a) STANDARDNI USLOVI:

- 1. Aerodromu je izdata potvrda za javnu upotrebu i u toku otvorenosti za polijetanje i slijetanje zrakoplova, biti će dostupan svim korisnicima pod istim uslovima;
- 2. Aerodrom se može koristiti samo pod uvjetima izdavanja aerodromske potvrde, i standardima, prakse i procedurama odobrenim u aerodromskom priručniku:
- 3. Nijedan avion ne može poletjeti ili sletjeti na aerodrom ukoliko odgovarajuće vatrogasno spasilačka i medicinska služba, kao i oprema za prihvat i opsluživanje takvog aviona nije spremna. Sve navedene usluge i oprema će biti spremni za djelovanje za vrijeme otvorenosti aerodroma:
- 4. Promjene u fizičkim karakteristikama aerodroma, uključujući, i izgradnju novih objekata, odnosno dograđivanje postojećih ili promjene vizuelne navigacije ne mogu biti obavljeni bez predhodnog konzultiranja i odobrenja od strane Direkcije za civilno zrakoplovstvo Bosne i Hercegovine;
- 5. Vlasnik potvrde će što je prije moguće izvjestiti Direkciju za civilno zrakoplovstvo Bosne i Hercegovine o promjenama koje su u svezi sa aerodromom kao što su promjene materijala na manevarskim površinama i promjenama karakteristike prepreka u zonama prilaza i polijetanja i kruženja i dr;
- 6. Bilo kakvo javno pravo prolaska ispod ili pored zone za slijetanje mora biti adekvatno označeno znacima upozorenja od opasnosti aviona;
- Aerodrom će biti dostupan za polijetanje i slijetanje u vremenu otvorenosti i ne može biti otvoren van tog vremena, osim ukoliko mu sukialano sa i pod uslovima navedenim u određenim aranžmanima ne bude odbrena dostupnost van određenog vremena;
- 8. Bez obzira na odredbu točke 1. dodatka 4.a. ovom potvrdom nemože se omogućiti drugim osobama da koriste aerodrom bez suglasnosti vlasnika potvrde;
- Aerodrom ispunjava uslove za aerodromski referentni kod: 4c.
