**Naslov:**

**Sigurnosni nalog o načinu korišćenja ATFMX statusnog indikatora u planu leta radi izuzimanja od dodijeljivanja ATFM slota (CTOT) pojedinim letovima koji prevoze vakcine protiv zarazne bolesti COVID-19.**

**Title:**

Safety order on the use of ATFMX Status Indicator in the Flight Plan for exemption from ATFM slot (CTOT) allocation concerning certain flights carrying COVID-19 Vaccines.

**Područje primjene:**

Ovaj sigurnosni nalog primjenjuje se na međunarodne IFR letove sa međunarodnih aerodroma u Crnoj Gori kojima se prevoze vakcine protiv zarazne bolesti COVID-19.

**Svrha:**

Ovim sigurnosnim nalogom se utvrđuje način korišćenja „STS/ATFMX i RMK/VACCINE” statusnog indikatora u rubrici 18 plana leta radi izuzimanja od dodijeljivanja ATFM slota (CTOT) onim letovima kojima se prevoze vakcine protiv zarazne bolesti COVID-19 i koji se smatraju kritičnim.

**1. Način korišćenja „STS/ATFMX i RMK/VACCINE” statusnog indikatora**

U cilju obezbeđivanja sigurne i brze isporuke vakcina protiv zarazne bolesti COVID-19, operatori vazduhoplova na letovima koji prevoze vakcine protiv zarazne bolesti COVID-19 mogu biti izuzeti od ATFM mjera za svaki let koji se smatra kritičnim.

Kritičnost prevoza vakcina protiv zarazne bolesti COVID-19 se utvrđuje u odnosu na karakteristike vakcine koja je primljena na prevoz, odnosno uticaja mogućeg ATFM kašnjenja u polijetanju na zahtjeve prevoza vakcine. Operatori vazduhoplova su odgovorni za utvrđivanje kritičnosti leta.

U slučajevima kada operatori vazduhoplova utvrde da je let kojim se prevozi vakcina protiv zarazne bolesti COVID-19 kritičan, operatori vazduhoplova mogu u rubrici 18 plana leta da navedu „STS/ATFMX i RMK/VACCINE” statusni indikator kako bi nadležnim jedinicama pružalaca usluga u vazdušnoj plovidbi najavili razlog za specijalni tretman predmetnog leta.

**2. Stupanje na snagu**

Ovaj sigurnosni nalog stupa na snagu narednog dana od dana objavljivanja na internet stranici Agencije za civilno vazduhoplovstvo, a primjenjuje se od **28. januara 2021. godine**.

**Scope:**

This Safety Order applies to international IFR flights from international airports in Montenegro carrying COVID-19 vaccines.

**Purpose:**

This Safety Order lays down the manner of use of the “STS/ATFMX and RMK/VACCINE” Status Indicator in the Item 18 of a Flight Plan to ensure exemption from the ATFM slot (CTOT) allocation for flights carrying COVID-19 vaccines and which are considered critical.

**1. Manner of use of the “STS/ATFMX and RMK/VACCINE” Status Indicator**

In order to ensure the safe and expeditious delivery of COVID-19 vaccines, aircraft operators for flights carrying COVID-19 vaccines may be exempted from ATFM measures for any flight deemed critical.

The criticality of the transport of COVID-19 vaccines is determined in relation to the characteristics of the vaccine received for transport, i.e. the effect of the possible take-off ATFM delay on vaccine transport requirements. Aircraft operators are responsible for determining flight criticality.

In cases where aircraft operators determine that the COVID-19 vaccine flight is critical, aircraft operators may in the Flight Plan Item 18 insert “STS/ATFMX and RMK/VACCINE” status indicator announcing to the competent air navigation service providers the reason for the special treatment of the flight.

**2. Entry into force**

This Safety Order shall enter into force on the day following the day of its publication on the website of the Civil Aviation Agency, and becomes effective on **January 28, 2021**.
