Na inicijativu: Agencija za civilno vazduhoplovstvo Crne Gore (u daljem tekstu: Agencija)

Initiated by: The Civil Aviation Agency of Montenegro (hereinafter: the Agency)

Na osnovu člana 6 stav 1 tačka 10 Zakona o vazdušnom saobraćaju („Službeni list CG“, br. 30/12, 30/17 i 82/20), Agencija je donijela:

Referentni propisi:

Pravilnik o kontinuiranoj plovidbenosti vazduhoplova i vazduhoplovnih proizvoda, djelova i uređaja i o odobravanju organizacija i osoblja koji obavljaju ove poslove („Službeni list CG“, br. 57/15, 69/15, 32/19, 108/20 i 33/21)

Referentna dokumenta:

EN 4179:2017 Kvalifikovanje i sertifikacija osoblja za ispitivanja bez razaranja.

Područje primjene:

Ovaj sigurnosni nalog primjenjiv je na sve organizacije za održavanje vazduhoplova u Crnoj Gori, koje su odobrene od strane Agencije i koje obavljaju poslove ispitivanja materijala bez razaranja (NDT) u vazduhoplovstvu.

Svrha:

Ovim sigurnosnim nalogom se vrši priznavanje nacionalnih organizacija/tijela za metodu ispitivanja materijala bez razaranja u vazduhoplovstvu (u daljem tekstu: NANDTB).

Pursuant to Article 6, paragraph 1, item 10 of the Law on Air Transport ("Official Gazette of Montenegro", No. 30/12, 30/17 and 82/20), the Agency adopted:

Reference regulations:

Regulation on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks "Official Gazette of Montenegro" , No. 57/15, 69/15, 32/19, 108/20 and 33/21).

Reference documents:

EN 4179: 2017 Qualification and approval of personnel for non-destructive testing.

Scope:

This order is applicable to all aircraft maintenance organizations in Montenegro, which are approved by the Agency and which perform non-destructive testing (NDT) in aviation.

The purpose:

This safety order recognizes national organizations / bodies for the non-destructive testing (hereinafter: NANDTB).

Razlog za izdavanje:

Nepostojanje NANDTB u Crnoj Gori.

Priznavanje NANDTB:

U svrhu ispunjavanja zahtjeva iz čl. M.A.606(f), 145.A.30(f) i CAO.A.035(f) Pravilnika o kontinuiranoj plovidbenosti vazduhoplova i vazduhoplovnih proizvoda, djelova i uređaja i o odobravanju organizacija i osoblja koji obavljaju ove poslove („Službeni list CG“, br. 57/15, 69/15, 32/19, 108/20 i 33/21), za odgovarajuće stručno osposobljenim osobljem koje sprovodi ili nadzire radove ispitivanja materijala bez razaranja (NDT) na vazduhoplovu ili na vazduhoplovnoj komponenti, priznaju se NANDTB odobreni od strane nadležnih vazduhoplovnih organa države članice EU.

Obuka NDT osoblja:

Ovlašćene organizacije za održavanje vazduhoplova koje obavljaju poslove ispitivanja materijala bez razaranja (NDT) u vazduhoplovstvu moraju obezbijediti da obuka NDT osoblja obavljaju organizacije ili osobe koje su pod kontrolom NANDTB određenog od strane nadležnog organa države članice EU.

Stupanje na snagu:

Ovaj sigurnosni nalog stupa na snagu narednog dana od dana objavljivanja na internet stranici Agencije za civilno vazduhoplovstvo, a primjenjuje se od 22. juna 2021. godine.

Reason for issuing:

Lack of NANDTB in Montenegro.

Recognition of NANDTB:

In order to meet the requirements of Art. M.A. 606 (f), 145.A.30 (f) and CAO.A.035 (f) of the Regulation on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks "Official Gazette of Montenegro", No. 57/15, 69/15, 32/19, 108/20 and 33/21), for suitably qualified personnel conducting or supervising non-destructive testing (NDT) on aircraft or on an aircraft component, shall be recognized NANDTB approved by the competent aviation authorities of an EU Member State.

Training of NDT staff:

Authorized aircraft maintenance organizations performing non-destructive testing (NDT) in aviation shall ensure that the training of NDT personnel is performed by organizations or persons under the control of the NANDTB designated by the competent authority of the EU Member State.

The entry into force:

This safety order shall enter into force on the day following that of its publication on the website of the Civil Aviation Agency, and it shall apply from 22 June 2021.
